



## Transportation System Plan Draft Moves Towards Council

After a year-and-a-half in the making, Cannon Beach is approaching the adoption of its first ever Transportation System Plan.

The plan--known as the TSP--serves multiple purposes.

The first is to act as a blueprint for the development of transportation in Cannon Beach over the next 20 years--that means exploring everything from driving to walking, biking, parking, safety, accessibility, accounting for growth and more.

The second function of the TSP--and this is a big one--is to help Cannon Beach secure grants towards the funding of those projects.

# Transportation System Plan Draft Moves Ahead

"The first box you check on any grant application is: is this project included in your transportation plan?" says Community Development Director Jeff Adams.

And, heretofore, Cannon Beach has never been able to check that box.

Unable to do so, the city found itself at a competitive disadvantage when applying for grants at the state and federal levels.



Cannon Beach, Adams says, is the only jurisdiction in Clatsop County to have never had a TSP.

Currently in draft form, the TSP has been assembled by the Portland-based consulting firm Parametrix, who've done on-the-ground studies in Cannon Beach, including assessments of traffic, parking, physical infrastructure (such as bridges) and more.

The cost of the TSP's development was offset by a grant Adams received from the Transportation and Growth Management (TGM) Program, a joint program of the Oregon Department of Transportation and the Oregon Department of Land Conservation and Development. The grant covered \$138,000 of the plan's total \$160,000 cost.

Working with Adams, Parametrix conducted multiple surveys and open-houses to gather feedback from the Cannon Beach community.

"The majority of what we heard," Adams says, "is the desire for a more bike and pedestrian friendly north-south connector." Especially during heavy traffic, Cannon Beach residents want to see safer ways to travel from one end of town to the other without driving. "Current pedestrian and bike traffic is pushed to the streets because we don't have a lot of sidewalks," Adams adds.

Parking is another significant concern.

"We got so much feedback on parking alone that we did a separate parking survey," Adams says.

Traffic congestion downtown is another priority.

The TSP contains proposals to alleviate these concerns, such as the creation of one-way streets downtown or the adoption of striped, timed or angled parking.

Adams stresses that the specific plan of say, a change in parking policy, are not prescribed by the TSP. Rather, he says, the TSP just offers study and options to move forward.

The adoption of the TSP--which is scheduled to come before a joint meeting of the Planning Commission and city council on May 10th then, presumably, moving towards adoption at the June 7th city council meeting--would provide but a potential roadmap. The options therein would have to be enacted, developed, and voted on separately by council.

"It's going to be a challenge for council to prioritize and institute those many options in the TSP," Adams says. "But the TSP gives the city council and decision makers the ability to say: we've got the survey results; the public comments have been positive and it's time to try some of these things."

# Cannon Beach Hires New Code Enforcement Officer

Meet Cannon Beach's new code enforcement officer: Luke Williams.

Before being hired in April, Williams worked at Sea Level Bakery. But public service has long been a part of his life.

"I somehow got the idea to join the army when I was in high school," Williams says. After graduating Williams spent six years in the Army Reserve.

Living in Tolovana Park with his wife, Williams is also a volunteer at the Cannon Beach Rural Fire Protection District.

He applied for the code enforcement position because "it sounded like a cool way to get my foot in the door here with the police department."

The responsibilities of a code enforcement officer are myriad. Williams, along with help from the Cannon Beach police, will be tasked with overseeing compliance in a number of areas, including: vacation rentals, signage, visibility issues, trimming trees, garbage and littering, animal control and more.

As code enforcement officer, Williams meets weekly with city staff to stay abreast of the latest developments, changes and city needs.

Chief of Police Jason Schermerhorn says the best way to file a complaint regarding a possible code violation is via the city's website. Schermerhorn says that the team will usually begin to look into the complaint on the same day it is received.

"With most of the code complaint cases we try to handle them at the lowest level--verbally at first," says Chief Schermerhorn. "And then we give them time to correct the issue before moving forward, progressively, with something like a municipal code violation."

While the code enforcement officer's job covers many different areas, Chief Schermerhorn says investigating short term rentals can be the most time consuming. When trying to pinpoint an illegal renter, Schermerhorn says, "Neighbors are always a big help with the investigation, taking pictures and documenting."

Chief Schermerhorn is especially pleased to hire an officer who lives in Cannon Beach and is familiar with the community.

"It's great to have someone like Luke who knows the town, who is with the fire department, and knows the area and locations," Schermerhorn says. "There is a huge difference between the six miles between here and Seaside. There's a lot more sensitivity to doing things here."


