PAVING WORK POSTPONED

As previously announced, Bayview Asphalt will be resurfacing several streets in Cannon Beach this fall. The paving was scheduled for Thursday, September 30, and Friday, October 1, but will have to be rescheduled due to rain in the weather forecast.

The locations slated for an

overlay are Elkland Court, Glenwood Court, Kimberly Court, E. Harrison (from Hemlock to Spruce) and the end of N. Larch Street just north of Ecola Creek. Property owners anticipated to be impacted by this project were notified, via letter, phone calls and social media.

Access to these streets may be restricted or adjusted during paving. Signage and/or flaggers will be in place. Thank you in advance for your patience during this necessary work.

The City of Cannon Beach is considering updates to its System Development Charges later this year.

After months of data gathering and technical analysis, while working with City Public Works staff, consultant FCS Group will present an overview of the proposed changes to City Council at the work session on Tuesday, October 12. Methodology for the three existing SDCs (water, wastewater, and stormwater) will be updated, and an SDC for parks will be established. A technical report addressing the methodology and calculation of the proposed charges will be available for review no later than Friday, October 8 at City Hall.

City Council will hold a public hearing on the SDC updates on Tuesday, December 7. All interested parties are invited to attend the hearing and express their views. Public comment will be accepted in writing or orally at the hearing. Written comments submitted ahead of the meeting must be received by noon on December 7 to be considered.

The SDC methodology was last updated in 2003, for water and wastewater. The methodology for stormwater has not been updated since 1996. The Public Works Department budgeted \$45,000 for this long overdue project and conducted an RFP process to hire a consultant in late 2020. FCS Group's proposal was selected based its expertise in this field, taking into account the City's positive experience with the company on past work (the recent utility rate study).

CITY HALL CLOSED TO VISITORS EXCEPT BY APPOINTMENT

Effective **August 27, 2021**, the following policies will be in place per <u>Administrative Order 21-02</u>:

NOTICE OF VACANCIES CITY COMMISSIONS, BOARDS & COMMITTEES

The City of Cannon Beach is seeking applications for the following vacancy:

TOURISM & ARTS COMMISSION: ONE (1) vacancy to a fill four-year term immediately. The sevenmember Tourism and Arts Commission develops grant guidelines and procedures and distributes and accounts for the monies in the "Tourism and Arts Fund" which are to be used by local non-profit groups to promote tourism and the arts in Cannon Beach. Each member shall have experience in one or more of the following areas: public relations, marketing, advertising, tourism, lodging, promotions, events promotion, art and/or publicity. The Tourism and Arts Commission holds its meetings as needed.

Note: Tourism and Arts Commission applicants are not required to reside in Cannon Beach and are eligible if he or she has worked, at least part-time, within the City of Cannon Beach for at least one year, immediately preceding appointment.

To be eligible to serve on a City committee, applicants must have resided within the city or its urban growth boundary during the one year immediately preceding appointment; or at the time of appointment, shall have owned real property located within the city or its urban growth boundary for at least one year immediately preceding appointment. HOW DO I SIGN UP FOR EMERGENCY NOTIFICATIONS?


- 1. Residential and business landline numbers are automatically included in the emergency contact list and do not require any action.

Cannon Beach has developed an extensive emergency preparedness plan that includes a network of evacuation routes that lead to high ground, with assembly areas and three permanent sites created to provide services during emergencies. Each site will provide for food distribution, sanitary facilities, shelter options, warming area and a medical station. **These sites also provide a place to store your personal emergency cache container**.

Join the Emergency Cache Container Program Today!

Evacuation Cache Sites represent the heart of emergency preparation effort. If you have not already joined the cache container program, we invite you to join us in planning ahead in the event of an emergency.

Your personal cache container(s) are stored in secure buildings at the Evacuation Cache Sites. The containers represent your personal; cache of supplies to assist you and/or your family until the emergency passes. The most important and essential items you can store are a tent and tarps, sleeping bags, canned or dried foods, a means to cook or warm them, water, and warm clothing. For your own comfort and well-being, having your own container(s) is by far the best option.

Freeze dried foods offer the longest lasting expiration dates, but some canned goods can last for five or six years before their "best by" dates. It is also recommended that a means to warm/cook your food be included.

Items not allowed in your container; firearms, ammunition or weapons, flammable or explosive material, biohazardous items, hazardous, dangerous or enviromentally harmful chemicals, perishable items, including alcohol.

Barrel owners will be given access twice a year to add or rotate stock to their barrels on the **third Saturday in April and October**.



PREVENTING CRIMES OF OPPORTUNITY

There has been a drastic increase of commercial and residential break-ins (burglary) in Clatsop County the last few weeks. Not all, but many have been crimes of opportunity with property being taken from unattended, unlocked vehicles and homes. Police Departments throughout the County are working hard to prevent crime. There are things that you can do to prevent crime too.

- Keep all doors and windows locked. If you have an alarm, activate it. If you don't have an alarm, get one if you can.
- Never leave keys in doors near glass. Hang spare keys out of reach from doors and windows.
- Never leave strollers, bikes, lawn mowers, tools, sporting equipment or any other valuable items sitting unattended around your home.
- Never leave your purse: in the cart at the supermarket or department store; on the floor next to your chair; hanging from the back of your chair, or on the chair next to you in restaurants or on public transportation; or in an unattended desk at work.
- Never leave laptops, purses, keys, cameras or other valuable items next to a door or visible from a window.
- Never leave valuables visible in your car. If you must leave them in your car unattended, place them in the trunk **before** you reach your destination.
- If you witness a burglary or other crime in progress, call 911 and report "Crime in Progress."
 Write down everything you see and keep notes in a safe place. Read your notes to the 911 operator.

VACCINE INFORMATION

Clatsop County and its local partners are striving to ensure that local residents can receive the COVID-19 vaccine in as timely and convenient a manner as possible.

Vaccines are being administered according to a multi-phase plan from the Oregon Health Authority.

GROUPS CURRENTLY ELIGIBLE FOR VACCINATIONS: All individuals ages 12 and over

PLEASE NOTE: Currently the Pfizer vaccine is the only one approved for individuals under 18 and will be used for all individuals 12 to 17 years old who want to be vaccinated. Immediate family members of those 12 to 17 years old can also receive the Pfizer vaccine at the same events.

Other individuals age 18 and over who wish to be vaccinated will receive the Moderna vaccine.
