CALL TO ORDER

Chair Walker called the meeting to order at 1:05 pm.

APPROVAL OF MINUTES

Motion Beck-Sweeney moved to approve the minutes of the May 14 and 15, 2018, meetings as corrected:

Bell seconded.

Vote: Walker, Kingwell, Beck-Sweeney, Toutain-Dorbec, Swedenborg, Bell and Sinkler voted AYE.

The vote was 7:0 in favor, and the motion passed.

Each member gave a review of their business and community interests.

- Beck-Sweeney: None.
- Bell: None
- Kingwell said that as a member of the Cannon Beach Gallery Group (CBGG), he feels he will recuse himself from voting on their event. He will give information to the group, however.
- Walker said she would recuse herself on the vote of the award for the Savor Cannon Beach event due to her relationship with the event coordinator, Gary Hayes.
- · Sinkler: None
- Swedenborg He feels he has no conflicts of interest no business interest but personal interest like everyone else.
- Toutain-Dorbec : None
- Walker said she would recuse herself on the vote of the award for the Savor Cannon Beach event due to her relationship with the event coordinator, Gary Hayes.

The commission began their deliberations. Each commissioner presented their numbers and gave a brief explanation of how they arrived at that number. After discussion some of the amounts were changed. Sinkler entered the amounts into the spreadsheet.

HALO Education Consultants – Rockdance Ecofest (ecologically based film festival). Six of the commissioners had decided not to fund the event. Sinker summed that it is in the concept stage with no full plan in place. The Commissioners expressed interest in a film festival, but did not feel it was developed enough to fund. Bell was the only member who wanted to award any funds (\$10,000) but after all the commissioners explained why they awarded \$0, he decided to strike his award amount. Consensus was it needed more planning and they wanted more facts and figures.

Northwest Trail Alliance – Klootchy Creek Trail System Herdener explained the legal position she was taking regarding this event. Her opinion is that it does not meet the state ORS description. She also said an event needs to fit the ORS as well as our City ordinance AND the TAC Guidelines. She did not feel this request did that. She said TAC and the City would be setting a precedent if this is funded, and the TAC must follow the Cannon Beach

ordinance and guidelines; where is the art nexus of this request and she does not feel that this is an 'event'.

Herdener pointed out that the Oregon legislature is working on clearly defining how the transient room tax funds can be used, but in the meantime, it is a grey area. In view of the litigation other cities are going through right now, she advises to be cautious. She pointed out that as the City Attorney, she serves the city and its citizens. She said the TAC could recommend an amount and the Council can decide what to do. Herdener said

The Commissioners each said the amount they would recommend:

Swedenborg – \$25,000 Beck-Sweeney - \$10,000

Toutain-Dorbec- \$0 "because it is a grey area as to whether it fits TAC and the ORS."

Sinkler- \$25,000 Bell - \$25,000

Kingwell - \$0 "believes they should have gone to another funding source"

Walker - \$0 " asked does this fit?"

Kingwell and Toutain-Dorbec expressed the opinion that this committee is not the correct mechanism to fund this project. Sinkler, Swedenborg and Bell all agreed it was a great idea and it could bring in more visitors in the future. More discussion followed.

TAC agreed to let Council decide on the amount and whether it fits the requirements.

Sinkler reviewed the input from each Commissioner for each event and then finalized the spreadsheet.

The Commission had no more to discuss and Walker asked for a motion regarding their recommendation to the City Council.

Chair Walker asked for a motion to approve the consensus amounts of the FY 2018 19 T AF grant awards.

Motion Walker moved to present the award consensus numbers to the City Council for discussion at their

June 12, 2018 work session; Beck-Sweeney seconded the motion.

Vote: Walker, Kingwell, Beck-Sweeney, Toutain-Dorbec, Swedenborg, Bell and Sinkler voted AYE, the

vote was 7:0 and the motion passed.

Herdener said she has enjoyed working with the TAC in the past and this is her last month with the city. She thanked them for their time, thought and effort.
