Public Works Department Report

Roads/Storm

- A large sink hole on Gower has been repaired. Crews found large tree debris under the pavement which caused the issue.
- Crews continue to check, maintain and repair if needed, the storm outfalls throughout town.
- Due to the recent weather new potholes have emerged. Crews are preforming pothole evaluation and repair.
- A sinkhole on Hemlock is slated for repair. North bound traffic will be rerouted down E. Adams during repairs. Surrounding property owners will be notified

Wastewater

- At the Midway Pump Station new controls and a dialer project is underway.
- Final design is wrapping up on the Headworks and UV Enclosure project which will soon go out to bid.
- Sewer repairs were made at 1st and Laurel due to root intrusion.

• Interesting note: Due to high rains 2.5 million gallons of wastewater were processed in two days. Without heavy rainfall the average for this time of year is approximately 600,000 gallons in two days.

Water

- Fire flow testing throughout town has been completed.
- The Poplar Water Line project is in the design phase. The goal is for construction to be complete by the end of the fiscal year.
- Crews continue with ongoing hydrant maintenance.
- A new isolation valve has been installed at 7th & Oak.
- Howell Spring Road repairs are due to begin.

Parks

- The time capsule was buried at Whale Park on February 14th.
- City of Cannon Beach Tree City USA application has been approved by the Arbor Day Foundation.
- The Whale Park planter project is complete.
- The concrete has been repaired from the time capsule removal and the sundial reinstalled at Tolovana Hall.

Admin

- Due to heavy winter storms and high tides there has been increased debris at beach access points. Please be patient if the area is not cleared right away. Crews are doing their best to keep things manageable between storms.
- Staff has been working with Mike Myers the City's new Emergency Manager.
- Staff is preparing for the 2019-2020 fiscal budget year.
